PARTIAL ASSIGNMENT OF OIL AND GAS LEASES

This Partial Assignment of Oil and Gas Leases (this "Assignment") is made by **ENCANA OIL & GAS (USA) INC.**, a Delaware corporation ("Encana") to **EXXON MOBIL CORPORATION**, a New Jersey corporation ("Assignee"), to be effective as of the later of May 14, 2010, or the effective date of each Oil and Gas Lease assigned (the "Effective Date").

1. Assignment. In consideration of the payment of TEN DOLLARS (\$10.00) and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Encana hereby sells, conveys, transfers, assigns, and delivers to Assignee, effective as of the Effective Date, an undivided twenty and eight hundred twenty-five thousandths (20.825%) right, title and interest in and to the following property (collectively, the "Assets"):

- (a) all interests related to the oil, gas and mineral leases described in Exhibit A, including, but not limited to, all working, royalty, overriding royalty, production payment, and other leasehold interests, insofar and only insofar as such oil and gas leases cover and affect the lands and depths (provided that, if no depths are specifically identified, then all depths are included) described in Exhibit A (collectively, but only to the extent so conveyed, the "Leases");
- (b) all oil, condensate, natural gas, salt water disposal and water wells associated with the Leases or lands pooled or unitized therewith, to the extent those wells are described on Exhibit A, whether producing, operating, shut-in or temporarily abandoned (the "Wells");
- (c) all other real property interests and other rights associated with the Leases or Wells, including mineral interests, surface owned in fee, easements, water rights and interests in lands pooled or unitized with the Leases;
- (d) all severed crude oil, natural gas, casinghead gas, drip gasoline, natural gasoline, petroleum, natural gas liquids, condensate, carbon dioxide and other hydrocarbons and other minerals or materials of every kind and description produced from the Wells, and either (i) in pipelines on the Effective Date or (ii) sold on or after the Effective Date and all proceeds attributable thereto;
- (e) all right-of-way agreements, easements and other agreements relating to the use or ownership of surface properties that are used or held for use for flow lines or any other purpose in connection with the production of oil, gas or other hydrocarbons from the Wells;
- (f) all equipment, fixtures and physical facilities of every type and description associated with the Leases and/or Wells;

(g) all Midstream Facilities (as defined in the Exploration Agreement referred to below), to the extent acquired or built and paid for by both parties, including but not limited to, equipment, tanks, pipe, rights of way, treating facilities and all other costs and expenses required to connect and tie in the Wells to a gas sales line;

(h) those certain contracts, commitments, agreements, and arrangements that relate to the Leases and/or Wells; and

(i) those franchises, licenses, permits, approvals, consents, certificates and other authorizations and other rights granted by governmental authorities and all certificates of convenience or necessity, immunities, privileges, grants and other rights, that relate to the Assets or the ownership or operation of any thereof (the "Permits").

2. Reservation. Encana reserves to itself, and there is hereby excluded from this Assignment, all rights in the oil and gas leases described on Exhibit A, other than that portion specifically conveyed hereby.

3. Assumption. Assignee hereby assumes its proportionate share of all of the costs, obligations and liabilities of Encana that relate to the Assets, including, without limitation, the terms, conditions and obligations of all agreements and contracts, including, but not limited to, all unit agreements, all joint operating agreements, all pooling agreements, all communitization agreements, oil and gas sales contracts, all gas processing agreements, all easements and rights-of-way, and all lease burdens (including, but not limited to, royalties, overriding royalty interests, production payments, net profits interests, carried working interests or similar burdens) that are recorded in the real property records of the above referenced county as of July 1, 2009 or as may have been subsequently agreed to by Assignor and Assignee under the Exploration Agreement (as defined below). Assignee also hereby assumes liability for its proportionate share of the costs of plugging and abandoning the Wells and all other wells drilled on the Leases by the parties hereto.

4. Exception to Conveyance. This Assignment does not operate to assign any Lease or real property requiring consent of the lessor or any third party to assign, if such consent has not been obtained as of the date of this Assignment; provided, however, that once such consent is obtained, such portion of such Lease or real property will be automatically vested in Assignee, without further action by Assignee or EnCana.

5. Warranty of Title. EnCana warrants title to the Assets by, through or under Encana or its affiliates but not otherwise, and EnCana will defend the Assets as to EnCana and its successors and assigns against any claims so arising.

6. Jagger Exploration Agreement. This Assignment is made subject to that certain Jagger Exploration Agreement between Encana and Assignee dated September 24, 2009 (the "Exploration Agreement"). In the event of conflict between the terms of the Exploration Agreement and the terms of this Assignment, the Exploration Agreement will control over this Assignment.

7. Disclaimers.

(a) Encana and Assignee agree that to the extent required by applicable law to be operative, the disclaimers of certain warranties contained in this Section 7 are "conspicuous" disclaimers for the purposes of any applicable law.

(b) OTHER THAN THE SPECIAL WARRANTY OF TITLE SET FORTH IN SECTION 5, ENCANA IS CONVEYING TO ASSIGNEE, AND ASSIGNEE IS ACCEPTING, THE ASSETS "AS IS," "WHERE IS," AND "WITH ALL FAULTS," AND ASSIGNEE IS ASSUMING ALL RISK WITH RESPECT TO THE ASSETS.

8. Further Assurance. The parties hereto covenant and agree that they will execute such further instruments and documents as may be necessary to effectuate and carry out the transaction contemplated by this Assignment

References in such exhibits to instruments on file in the public records are notice of such instruments for all purposes. Unless provided otherwise, all recording references in such exhibits are to the appropriate records of the counties in which the Assets are located.


