CONVEYANCE

For and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Paloma Partners II, LLC, a Delaware limited liability company, 1021 Main Street, Suite 2600, Houston, Texas 77002, hereinafter referred to as "Assignor," does hereby grant, sell, convey, and assign unto Exxon Mobil Corporation, a New Jersey corporation, c/o XTO Energy Inc., 810 Houston Street, Fort Worth, Texas 76102, hereinafter referred to as "Assignee," subject to the reservations and other terms herein contained, all of Assignor's right, title and interest in and to the following described properties, rights and interests (collectively the "Properties"):

(a) The oil, gas and/or mineral leases and options to acquire oil and gas leases and the lands covered thereby, described on Exhibit "A" hereto, and any ratifications and/or amendments to such leases, whether or not such ratifications or amendments are described on such Exhibit "A" (collectively the "Leases"), together with all rights, privileges, benefits and powers conferred upon the holder of the Leases with respect to the use and occupation of the lands covered thereby;

(b) All rights with respect to any pooled or unitized acreage that includes all or part of any Lease, and other interests in the lands covered by the Leases, whether such interests are specifically described in Exhibit A, and even though Assignor's interest in such lands may be incorrectly described in or omitted from Exhibit A;

(c) All rights, titles and interests of Assignor in and to, or otherwise derived from, all presently existing and valid oil, gas and/or mineral unitization, pooling, and/or communitization agreements, declarations and/or orders (including, without limitation, all units formed under orders, rules, regulations, or other official acts of any federal, state or other authority having jurisdiction, and voluntary unitization agreements, designations and/or declarations) relating to the properties described in subsections (a) or (b) above (the "Units"); and

(d) All surface fee interests, easements, permits, licenses, servitudes, rights-of-way, surface leases and other surface rights appurtenant to, whether part of the premises covered by the Leases or Units or otherwise, and used or held for use primarily in connection with, the Leases or Units.

This Conveyance is subject to the following reservations and terms:

(1) With respect to each of the Leases, Assignor specifically excepts from this Conveyance, and reserves unto itself, and its successors and assigns, on a Lease-by-Lease basis, an overriding royalty interest in all oil, gas and other minerals produced and marketed from the lands covered by such Lease equal to the positive difference, if any, of

25% minus all leasehold burdens that affect such Lease (the "Overriding Royalty Interest"), it being the intent of Assignor to assign to Assignee an undivided net revenue interest of seventy-five percent (75%) in each Lease hereby assigned. The Overriding Royalty Interest in any Lease shall be proportionately reduced in such Lease if (i) the Lease covers less than 100% of the fee simple mineral estate in the lands covered by the Lease, in which case the Overriding Royalty shall be reduced to the proportion thereof which the fee simple mineral estate covered by such Lease bears to 100%, or (ii) if Assignor owns less than one hundred percent (100%) of the entire leasehold estate in the Lease, in which case the Overriding Royalty Interest shall be reduced to the proportion thereof which the interest owned by Assignor in such leasehold estate bears to one hundred percent (100%). The Overriding Royalty Interest shall apply to any extension or renewal of any Lease, or any new lease or leases covering the lands covered by such Lease or any part thereof, taken by Assignee or an affiliate thereof within six (6) months after the termination of such Lease; provided, however, if burdens, other than the Overriding Royalty Interest, in any such extension, renewal or new lease, increase, or decrease, as a result of an increase, or decrease, in the lessor's royalty applicable to such extension, renewal or new lease, the amount of Overriding Royalty Interest shall be reduced, or increased, accordingly in the amount of such increase, or decrease, so that, if possible, Assignee will maintain an undivided seventy-five percent (75%) net revenue interest in such extension, renewal or new lease. Additionally, the Overriding Royalty Interest shall be paid and delivered to the credit of Assignor free and clear of all of the risks, costs and expenses of development and operation, and all costs and expenses incurred by Assignee in the gathering, transportation, compression, treatment and marketing of production prior to the point of first sale of such production, except that the Overriding Royalty Interest shall bear all reasonable costs and expenses incurred by Assignee pursuant to arms-length contracts with unaffiliated third parties for the gathering, transportation, compression, treatment and marketing of production prior to the point of first sale of such production, and shall bear its proportionate share of ad valorem, production, severance or other excise taxes and. The Overriding Royalty Interest shall impose no obligation upon Assignee, either expressed or implied, to keep and maintain the Leases in force and effect either by paying rentals, compensatory royalties, or other sums, or by drilling or developing the lands covered by same. Assignee shall have the right, at its sole election and without further consent from or joinder of Assignor, to pool and unitize the Overriding Royalty Interest and one or more of the Leases with other leases or lands, in any manner or method as solely determined by Assignee. Where oil or gas is produced from any unit so formed, Assignor shall be entitled to receive on production from such unit only such portion of the Overriding Royalty Interest as the amount of surface acreage of the land affected by such interest and placed in such unit bears to the total surface acreage included in such unit.

(2) Assignor will execute and deliver all such other and additional instruments, notices, releases, and other documents and will do all such other acts as may be necessary to more fully assign to Assignee or its successors or assigns all of the respective rights and interests herein and hereby granted or intended to be granted.

(3) As part of the consideration for the execution and delivery of this instrument by Assignor, Assignee agrees to all of the terms and provisions hereof and joins in the execution of this instrument to evidence this agreement.

(4) This Conveyance is executed and delivered pursuant and subject to the terms of that certain Agreement of Sale and Purchase dated November 17, 2010, (the "Agreement"), between Assignor as "Seller" and Assignee as "Buyer." Assignor and Assignee intend that the terms of the Agreement remain distinct from and not merge into the terms of this Conveyance. Such Agreement contains certain representations, warranties, and agreements between Assignor and Assignee, some of which may survive the delivery of this Conveyance, as provided for therein, but third parties may conclusively rely on this Conveyance to vest title to the Properties in Assignee. Specifically, but not by way of limitation, Assignor and Assignee agree (i) that the Properties do not include the "Excluded Properties" so identified in the Agreement and (ii) the "Disclaimer" provisions set forth in Section 3.13 of the Agreement are incorporated herein by reference with substitution therein of the words "Assignor" for "Seller," and "Assignee" for "Buyer."

(5) This Conveyance may be executed in a number of counterparts, each of which for all purposes is to be deemed an original, and all of which constitute collectively, one instrument. It is not necessary that each party hereto execute the same counterpart so long as identical counterparts are executed by each such party hereto. The signature page of each counterpart may be combined by either party and attached to one multiple counterpart for recording purposes and such recorded counterpart with signature pages attached shall constitute one and the same Conveyance.


