- 5. To designate a unit operator of, and a unit well for, each of the proposed units as may be appropriate.

To approve exceptions to the spacing provisions of Office of Conservation Order No. 361-A-1, effective October 1, 1972 (applicable to the Hosston Zone, Reservoir A), Office of Conservation Order No. 361-B, effective October 1, 1973 (applicable to the Cotton Valley Formation, Reservoir A), and of Office of Conservation Order No. 361-E, effective July 16, 1996 (applicable to
