Notice is hereby given that **SAMSON CONTOUR ENERGY E&P**, **LLC** plans to apply to the Commissioner of Conservation for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters:

- To establish rules and regulations and to create four (4) drilling and production units for the exploration for and production of oil and gas from the Fredericksburg Lime, Reservoir C, in the Converse Field, Sabine Parish, Louisiana, said proposed units designated FRED RC SUA through FRED RC SUD, all as shown on the plat attached hereto and made a part hereof.
- 2. To unitize all separately owned tracts, mineral leases and other property interests within the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
