APPLICATION FOR PUBLIC HEARING

Petrohawk Operating Company hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Haynesville Zone, Reservoir B, in the Caspiana Field, Bossier and Caddo Parishes, Louisiana:

- 1. To authorize Petrohawk Operating Company to drill, designate and utilize five (5) alternate unit wells for HA RB SUP generally at the locations and in the manner shown on the plat attached hereto and made a part hereof;
- 2. To establish that the proposed alternate unit wells are necessary to efficiently and economically drain portions of the Haynesville Zone, Reservoir B, underlying HA RB SUP;
- 3. To authorize the unit allowable for these units to be recovered from the existing unit well, the proposed alternate unit wells, or any combination thereof, at the discretion of the operator;
- 4. To provide that with respect to any horizontal lateral drilled to the Haynesville Zone, Reservoir B, in or to serve HA RB SUP where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir B, the distance to any unit boundary or offset well will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus; and
- 5. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Haynesville Zone, Reservoir B, in the Caspiana Field, Bossier and Caddo Parishes, Louisiana, was defined in Office of Conservation Order No. 191-H-6, effective May 28, 2008, and was redefined as to HA RB SUP in Order No. 191-H-57, effective July 7, 2009.

The subject matter of this application does not require the issuance of a pre-application notice.

The actual paths of the proposed alternate unit wells may differ from the paths depicted on the attached plat. However, in no event will the wells be perforated closer than 330 feet to any unit line.
