Creation of additional units for Hosston Formation, Reservoir A
and Jurassic Zone, Reservoir A
Martin Field, Red River Parish, Louisiana

Dear Commissioner Welsh:

Application is hereby made on behalf of **ENCANA OIL & GAS (USA), INC.** for the calling of public hearings, after legal notice, to consider evidence relative to the issuance of orders pertaining to the following matters:

Cotton Valley A Sand, Reservoir A

1. To dissolve the units designated CV A RA SUB and CV A RA SUC, in the Martin Field, Red River Parish, Louisiana, previously established by Office of Conservation Order No. 1137-D-1, effective September 13, 1984.
2. To consider such others matters as may be pertinent.

Hosston Formation, Reservoir A

1. To create one (1) additional drilling and production unit for the exploration for and production of gas and condensate from the Hosston Formation, Reservoir A, in the Martin Field, Red River Parish, Louisiana, said unit to be designated HOSS RA SUY, as shown on the plat attached hereto and made a part hereof.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. Except to the extent contrary herewith, to extend to the proposed additional unit all pertinent provisions of Office of Conservation Order No. 1137-C, effective April 30, 1982, as amended and supplemented by the 1137-C Series of Orders, and applicable statewide orders.
4. To consider such others matters as may be pertinent.

The Hosston Formation, Reservoir A, in the Martin Field, Red River Parish, Louisiana, was previously defined in Office of Conservation Order No. 1137-C, effective April 30, 1982, and is hereby redefined as being that gas and condensate bearing formation encountered between the depths of 6,780 feet and 9,760 feet (electrical log measurements) in the Amerada Hess Corporation – Morgan Gas Company No. 1 Well, located in Section 14, Township 13 North, Range 9 West, Red River Parish, Louisiana, in accordance with EnCana's previously-filed application considered at a hearing held on June 25, 2008, under Docket No. 08-855.

Jurassic Zone, Reservoir A

1. To create three (3) additional drilling and production units for the exploration for and production of gas and condensate from the Jurassic Zone, Reservoir A, in the Martin Field, Red River Parish, Louisiana, said units to be designated JUR RA SUK, JUR RA SUL and JUR RA SUX, as shown on the plat attached hereto and made a part hereof.

2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
3. Except to the extent contrary herewith, to extend to the proposed additional units all pertinent provisions of Office of Conservation Order No. 1137-E, effective August 1, 2006, as amended and supplemented by the 1137-E Series of Orders, and applicable statewide orders.
4. To consider such others matters as may be pertinent.

The Jurassic Zone, Reservoir A, in the Martin Field, Red River Parish, Louisiana, was previously defined in Office of Conservation Order No. 1137-E, effective August 1, 2006.

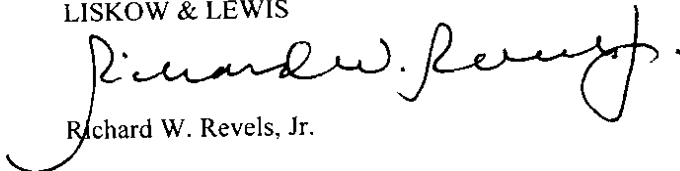

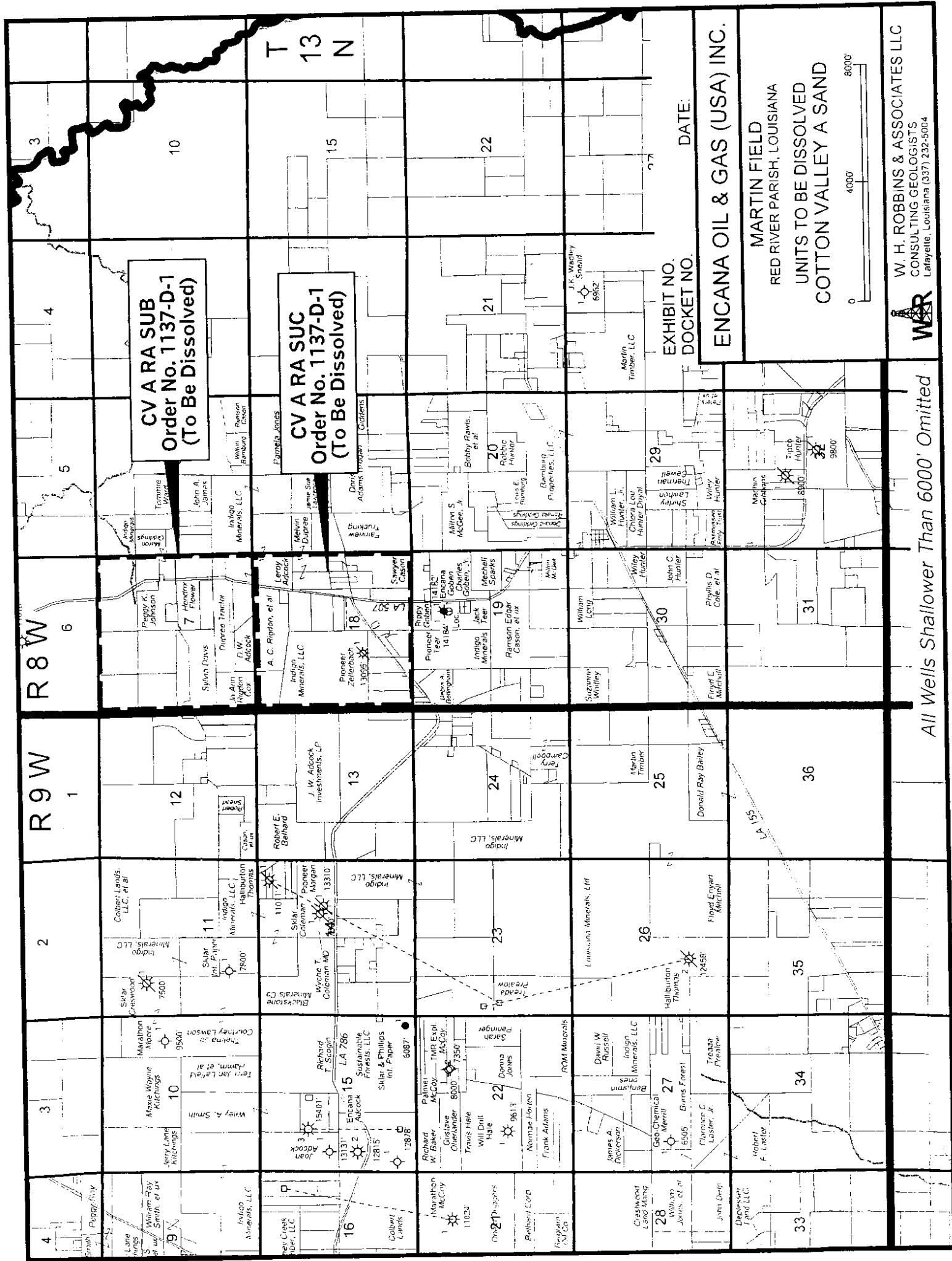
