AETHON ENERGY OPERATING LLC ("Applicant") hereby respectfully applies for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, in the Caspiana Field, Caddo Parish, Louisiana:

1. To redefine the Haynesville Zone, Reservoir A, INsofar AND ONLY INsofar as to the existing unit designated HA RA SUWW, said unit being shown on the attached plat, as being the stratigraphic equivalent of that gas and condensate bearing zone encountered between the depths of 9,550 feet and 11,350 feet (electrical log measurements), in the Aethon Energy Operating LLC (formerly O. B. Mobley)--Foster No. 1 Well, located in Section 14, Township 15 North, Range 13 West, DeSoto Parish, Louisiana.
2. To confirm the unit designated HA RA SUWW as remaining in full force and effect as a drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Caspiana Field, as redefined in the manner set forth above.
3. To provide that if the horizontal portion of a well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, as redefined, the distance to any unit boundary and offset well(s) will be calculated based on the distance to the nearest perforation in the well and not on the penetration point or terminus of the well in the Haynesville Zone, Reservoir A.

4. Except insofar as set forth above, to confirm and continue in full force and effect the provisions of Office of Conservation Order No. 191-H, effective August 28, 2007, as amended and supplemented by the 191-H Series of Orders, the units created thereby, and of all applicable Statewide Orders.

5. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, Reservoir A, in the Caspiana Field, Bienville, Bossier, Caddo and DeSoto Parishes, Louisiana, was defined in Office of Conservation Order No. 191-H, effective August 28, 2007.

Any pertinent data concerning this application will be available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 N. Causeway Boulevard, Suite 204, Metairie, Louisiana 70002-7216. Any person wishing to inspect any such data should call Mr. Doffie Ross at (504) 834-8112 during normal business hours in order to arrange a date and time for such inspection. A copy of any such pertinent data which is not otherwise available from the Office of Conservation can be obtained from Applicant at the expense of the requesting party.

By letter dated April 1, 2021, Applicant gave notice, in accordance with the Revised Rules of Procedure, of its intention to apply for a public hearing concerning these proposals and set April 28, 2021, as the tentative date for the pre-application conference. No conference request was received; accordingly, no pre-application conference will be held.

Pursuant to the aforesaid Rules of Procedure, Applicant has made a reasonable effort to obtain the names and addresses of all Interested Owners, Represented Parties and Interested Parties to whom notice of this application is being sent and has attached hereto a list of the names and addresses of such parties. A copy of this letter, and of the attached plat, is being sent to the District Manager of the Shreveport District of the Office of Conservation and to each of the Interested Owners, Represented Parties and Interested Parties as shown on the attached list.

Applicant will provide for posting of a copy of the Legal Notice of this hearing, and the enclosed plat, at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Caspiana Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, enclosed herewith is our check payable to the Office of Conservation covering the application fee.
