> The Hosston Formation in the Black Lake Field, Natchitoches and Winn Parishes, Louisiana was defined in Office of Conservation Order No. 686-B, effective September 20, 2005.

For the above Zone and Formtion

- To establish rules and regulations governing the exploration for and production of gas and condensate from the said units.
- 2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the units so created, with each tract sharing in unit production on a surface acreage basis of participation.
- 3. To consider such other matters relating to the subject reservoir as may be appropriate and justified by the evidence presented at the public hearing.
