Dear Commissioner Welsh:

Application is hereby made on behalf of SWEPI LP for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters:

- To establish rules and regulations and to create fifteen (15) drilling and production units 1. for the exploration for and production of gas and condensate from the Jurassic Zone, Reservoir A, in the Grogan Field, Sabine Parish, Louisiana, said units to be designated JUR RA SUA through JUR RA SUO, all as shown on the plat attached hereto and made a part hereof.
- To force pool and integrate all separately owned tracts, mineral leases and other property interests within each of the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
- To provide that any future wells drilled to the Jurassic Zone, Reservoir A, within or 3. outside of the units created herein, should be located in accordance with the provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
- To provide that the Commissioner of Conservation should be authorized to reclassify the Jurassic Zone, Reservoir A, by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir changes and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
- To consider such others matters as may be pertinent. 5.

The Jurassic Zone, Reservoir A, in Grogan Field, is hereby defined as being the stratigraphic equivalent of that gas and condensate bearing zone encountered between the depths of 10,215 feet and 13,930 feet (electrical log measurements) in the Phillips Petroleum Company – Johnson DDD No. 2 Well, located in Section 3, Township 9 North, Range 11 West, Sabine Parish, Louisiana.

Any pertinent data, including well logs, not available at the Office of Conservation, may be obtained **AT THE COST OF THE REQUESTING PARTY** from Bill Dale with W. H. Robbins & Associates, L.L.C., 302 LaRue France, Lafayette, Louisiana 70508, Telephone Number (337)232-5004.
